VBSR 2009/2010 Biennium Issues

ISSUE 1

H. 436-Vermont Yankee Decommissioning (2009)

H. 436 provided a mechanism to ensure that Entergy Vermont Yankee would have in place adequate financial instruments to ensure decommissioning of the nuclear reactor and the facility site prior to any spin-off of the facility. VBSR supported the final bill as an important step to protect Vermont businesses and other Vermont taxpayers by ensuring that the decommissioning fund would be adequate and accessible before any ownership spin-off could occur. VBSR supported a “yes” vote. The final was vote 22-4 in the Senate and 85-52 in the House.

Governor Jim Douglas vetoed the bill and it never became law.

Note: Although the House voted on a related bill in 2010 (H.589), VBSR found the 2009 bill preferable because it was broader in scope and had more aggressive time-lines.

ISSUE 2

S.115-Civil Marriage (2009)

The results of VBSR’s 2008 public policy member survey showed that 98% of the respondents supported Freedom to Marry. VBSR believes that laws that recognize equality lead to strong communities and a strong business climate. The Civil Marriage bill was passed by the legislature, vetoed by Governor Douglas, and then the legislature overrode the veto and it became law. VBSR supported a “yes” vote on the override. The Senate over-ride vote was 23-5 and the House override vote was 100-49.

Note: Vermont is the first state Legislature to grant marriage equality through legislation rather than by court order.

ISSUE 3

H.446-Renewable Energy (2009)

H.446 included “standard offer” contracts for renewable energy (feed-in-tariffs) and the authority for the creation of municipal Clean Energy Assessment Districts. The standard offer provisions require utilities to purchase renewable power at above-market rates to provide incentives for renewable power generation (the law has an overall program cap of 50 MW). The Clean Energy District provisions allows municipalities to finance residential and business renewable energy and energy efficiency projects though debt financing. Feed-in-tariffs and Clean Energy Assessment Districts were VBSR 2009 priority legislative actions to move Vermont forward to a sustainable energy future. VBSR supported a “yes” vote. The final House vote was 91-49 and the final Senate vote was 16-10.

ISSUE 4

S.88-Health Care Reform (2010)

For over 16 years, VBSR has advocated for a health care system that provides universal access to an integrated system of care, which is decoupled from employment and publicly financed. S.88 provides a step toward that goal by requiring the creation of three design options for a reformed health care system for Vermont. S.88 as originally passed by the Senate was VBSR’s preferred bill (and used for the Senate score, 28-2) but VBSR also supported the final bill (used for the House score, 91-42).

ISSUE 5

S.289-Vermont Yankee Relicensing (2010)

This bill, if passed, would have given legislative approval for 20 years additional operation of the Vermont Yankee Nuclear Power Station and the continued on-site storage of its spent nuclear fuel. VBSR’s position is that the relicensing of ENVY is not a safe or cost-effective solution to our long-term energy needs due to the continued radioactive waste storage near the banks of the Connecticut River, continued safety and deferred maintenance issues, lack of adequate financial capability and responsibility, and overall fiscal prudence. VBSR advocated for a “no” vote on this bill. The bill failed in the Senate by a vote of 4-26. The House did not take up a similar bill.

VBSR 2009/2010 Biennium Issues

ISSUE 6

Unemployment Insurance Trust Fund - S.290 (2010)

Fund solvency was a 2010 VBSR legislative priority. VBSR believes it is imperative to avoid burdensome debt to the federal government and the associated increased strain on our state budget. VBSR also advocated for systematic changes (indexing of employer contributions) to ensure fiscal sustainability of the fund over the long term. VBSR supported significant increases in the employer contribution formula—even more aggressive than the final bill—and opposed the Administration’s proposed cuts to the maximum weekly benefit.

VBSR did support some benefit reforms to curtail “gaming” of the system by some seasonal employees, while advocating for relief for seasonal industry employers who actively find off-season employment for their workers (this proposal did not get included in the final legislation).

VBSR also supported small contributions from employees (our proposal did not become part of the bill). In the end, the final legislation was a difficult compromise that VBSR supported. A “yes” vote on the final bill was supported by VBSR. The Senate vote was 26-0 and the House vote was 133-9.

ISSUE 7

Benefit Corporation- S.263 (2010)

This VBSR-led initiative enables the creation of a new corporate form offering entrepreneurs and investors the option to build and invest in businesses that meet higher standards of corporate purpose, accountability and transparency. Fiduciary duty is redefined by requiring consideration of interests beyond shareholders, including the corporation’s employees and suppliers, the local and state economy, and the environment. The bill passed the Senate on a voice vote and passed the House on a 108-30 roll call.

OUR SCORING PROCESS

If a member did not serve both sessions, we only scored their votes for the session they served.

If a member was absent for a vote, that vote was counted as a negative vote.
